Dublin City Council Culture Company are looking for warm individuals who have a passion for storytelling and culture, who can bring the memories of 14 Henrietta Street to life, and can work with us to build and enrich the museum story over time.

We are seeking to recruit additional members to a panel of part-time paid-position tour guides to join our museum team at *14 Henrietta Street*. Ideal candidates will come from a diverse range of backgrounds in terms of their academic, professional and life experiences. All will share a love of Dublin city, community, and history.

If you like the idea of helping our visitors to feel a sense of ownership and connection with the stories of *14 Henrietta street*, we want to hear from you.

## **About 14 Henrietta Street**

Set in a Georgian townhouse, *14 Henrietta Street* tells the story of the building's shifting fortunes, from family home and powerbase to courthouse; from barracks to its final incarnation as a tenement house. Built as a townhouse for the elite of Dublin, 14 Henrietta Street was turned into tenements in the 1880s, with some 100 people living there by 1911. It remained a tenement house until the last families left in the 1970s.

Through video and storytelling, the visitor experience at 14 Henrietta Street tells the story of the lives of the people who lived there, and how social change impacted on them over time. People can experience 14 Henrietta Street through pre-bookable guided tours, which run hourly from 10am to 4pm Wednesday to Saturday and from 12 noon to 4pm on Sundays.

#### Aims of 14 Henrietta Street

➤ Share – We tell stories

By retelling the story of the lives of the people of 14 Henrietta Street and those that experienced tenement life in Dublin.

➤ Engage – We make connections

By listening and talking, we make connections with visitors, citizens, historians, local residents, former residents and their families. Sharing the experience of <u>14 Henrietta Street</u> and its stories, and continuing to learn from the memories and knowledge of others.

➤ Discover –We uncover history

By continuing to research the house and its occupants, collecting the living memories of former tenement residents, creating a record of the urban and social history of our city.

## **Role Specification**

This role is part-time and paid. Shifts are 4, 6 or 8 hours long. A weekly roster system is in place and each member of the panel is offered hours depending on how busy the tour schedule is. Shifts may extend beyond museum opening hours for private events or evening programming.

- Welcoming visitors to 14 Henrietta Street
- Conducting guided tours of 14 Henrietta Street as per your training
- Facilitating visitors' experience by telling stories related to 14 Henrietta Street and encouraging visitors to share their stories.
- Checking in visitors and administering admission tickets
- Handling retail and on site ticket sales
- Operating audio visual or other appropriate equipment to support tours or events
- Assisting the team in preparing for and facilitating events in the museum, both during and outside of museum opening hours
- Ensuring that any rules for visitors are observed and being responsible for your own and visitor security and safety at the site
- Additional light administrative duties as required
- Keeping reception area and other site facilities clean and tidy

#### **Person Specification**

The ideal person for this role will have:

- A demonstrable interest, knowledge, or expertise in relevant subjects such as social history, conservation, heritage, community development, arts and culture
- Relevant experience of working in a customer-facing environment
- Relevant experience and qualifications in tour guiding (or equivalent)
- Excellent communication, interpersonal and storytelling skills
- An adaptable, open and confident personality
- A willingness to be a team player and work flexibly
- A qualification in an arts or history related field is desirable
